



Privacy policy

Your privacy is important to us and therefore we want you to feel confident about what personal data we collect and how we use it. This Privacy Policy is aimed to our suppliers, business partners, job seekers and visitors to our website.

How do we process your personal data?

Suppliers and business partners

Commentor process contact information about you who is a contact person or employee of one of our suppliers or business partners. We do this to administer our relationship with the supplier or business partner. The legal basis for the processing is the completion of contracts and our legitimate interest in administering our relationships with suppliers and business partners. The personal data used for this purpose is stored as long as you are the contact person of the supplier or business partner and then at most 2 years after the contractual relationship has ended.

As regards contact details relating to invoices for services and goods purchased and sold, the legal basis for processing is the completion of contracts and to the extent that it details a legal obligation, such as the Accounting Act. This can be information such as contact person, address, phone number, e-mail, invoice information and payment information. The personal data used for this purpose is stored as long as we are required to store the data according to applicable law and for as long as necessary for the contract.

Job search

Commentor process your contact information and other relevant information that you provide to us when you submit an application to us. We do this to handle your application. The legal basis for this treatment is a legitimate interest in managing the recruitment process. Personal data processed for this purpose is stored during the recruitment process. In the event that we want to save your data for future recruitments, we will request your consent. If you become an employee of ours, your personal data will be stored during employment. If you are not employed, your data will be deleted, destroyed and discarded when the recruitment process is completed.

Visitors to the site

Commentor will not collect any personally identifiable information about you through this website unless you have provided the information to us voluntarily. To answer your questions or fulfill a request from you, it may be necessary to ask for personal information. We may use this information to respond to a request from you by letter, email or phone. The purpose is then to fulfill your request.

When you visit our website, we automatically collect web statistics that contain:

- City
- Region
- Postal code

- ISP/organization
- Rapporteur
- IP number
- Number of visits
- Page views
- Total visiting time
- Last visit length
- Date of first visit
- Operating system
- Browser

We do this to produce statistics on how many people visit our website. The legal basis for this processing is our legitimate interest in developing and improving our website. We de-identify the logs directly and no personal data is saved.

Who do you share my personal data with?

Commentor may share your personal data with authorities if such disclosure is provided by law. We can also share business partners when needed and after balancing interests.

We will not sell your personal data to third parties.

Your rights

You can request a copy of the information you would like to know and verify the information we have about you.

You have the right to correct incorrect or non-complete information about yourself.

You have the right to request the deletion of your personal data in cases where the data is no longer necessary for the purpose for which it was collected. However, there may be legal obligations that prevent us from immediately deleting portions of your data.

You have the right to withdraw your continued consent for future processing.
